There are 261 eligible voters, 106 voted, 0 were removed as challenged ballots. A total of 106 were tallied for a turnout of 40.61%. 88 of these voters voted online and 18 voted via phone. For all other ratification ballots, the highlighted statement meets the majority requirement and indicates the results on the question.


