



## Alaska Airlines Council 39 LEC Officer Elections

There are 545 eligible voters, 242 voted, 1 were removed as challenged ballots. A total of 241 were tallied for a turnout of 44.22%. 184 of these voters voted online and 57 voted via phone. For all other ratification ballots, the highlighted statement meets the majority requirement and indicates the results on the question.
