



## Alaska Airlines Council 19 SEA LEC Officer Election

There are 2410 eligible voters, 767 voted, 0 were removed as challenged ballots. A total of 767 were tallied for a turnout of 31.83%. 609 of these voters voted online and 158 voted via phone. For all other ratification ballots, the highlighted statement meets the majority requirement and indicates the results on the question.
