There are 3012 eligible voters, 907 voted, 0 were removed as challenged ballots. A total of 907 were tallied for a turnout of 30.11%. 817 of these voters voted online and 90 voted via phone. For LEC elections, the Ballot Certification Committee has noted the winning candidate in each election. For all other ratification ballots, the highlighted statement meets the majority requirement and indicates the results on the question.
