



Alaska Airlines Council 19 LEC Officer Elections

There are 1751 eligible voters, 568 voted, 2 were removed as challenged ballots. A total of 566 were tallied, 1 ballot was blank for a turnout of 32.32%. 418 of these voters voted online and 148 voted via phone. For LEC elections, the Ballot Certification Committee has noted the winning candidate in each election. For all other ratification ballots, the highlighted statement meets the majority requirement and indicates the results on the question.




